RESOLUTION NO.10-03-19

RESOLUTION RECOMMENDING THE ISSUANCE OF NOTICE OF AWARD FOR THE DISPOSAL OF CROSSWIND TO JOHN-JOHN PAGSOLINGAN

WHEREAS, the San Carlos City Water District Disposal Committee conducted public bidding under Board Resolution 11-02-18 for the disposal of Crosswind on a "As is where is" basis in accordance with COA Circular No. 89-296 dated January 27, 1989;

WHEREAS, Invitation to Bid for the Disposal of Crosswind on a "As is where is" basis were posted on SCCWD website, New Public Market Bulletin Board and SCCWD Bulletin Board;

WHEREAS, after 2(two) failed public biddings held on May 17, 2019, and June 6, 2019 under Disposal Committee Resolution No. 06-01-19;

WHEREAS, Appraisal Committee submitted re-appraise value for the Disposal of Crosswind for new schedule of public bidding.

WHEREAS, 2(two) more public biddings were held on September 20, and October 14, 2019 but both are declared Failure of Bidding due to only one bidder submitted its bid.

WHEREAS, COA Circular No. 89-296 dated January 27, 1989 states that " for justifiable reasons and as demanded by the exigencies of the service, disposal thru negotiated sale may be resorted to..."thus the Disposal Committee under Resolution No. 10-02-19 recommends the Sale thru Negotiation as the disposal mode to be use.

WHEREAS, on October 23, 2019, a sale thru negotiation were conducted with the lone bidder, the bidder offered the bid amount of Php180,000.00 for the Disposal of Crosswind.

WHEREAS, the offer of the bidder is greater than the floor price appraised by the Commission On Audit(COA) thereby provides advantages to the government.


WHEREFORE, on unanimous accord by all the members of the Disposal Committee, be it RESOLVED as it is hereby RESOLVED to recommend the issuance of Notice of Award for the Disposal of Crosswind.
